What qualification will I gain?

Level 5 qualification in Management & Leadership – Extended Diploma, Diploma, Certificate or Award

- Extended Diploma 62 credits (all units) must be completed
- Diploma any combination of units to a minimum of 38 credits must be completed
- Certificate any combination of units to a minimum of 13 credits must be completed
- Award a minimum of 6 credits must be completed

How will it be assessed?

Written and practical assignments and a work based project
